



PARKING REGULATIONS

Art. 1 - Cars heading to the parking lot, already from the access aisle, must reduce the speed to 10 Km h and at times of highest traffic these must queue up one to the other being absolutely forbidden to overtake and in the case of waiting it is obligatory to turn off the engine.

Art. 2 - **In the parking lot, access and parking is prohibited for campers, caravans, motor vehicles towing trailers, as well as vehicles exceeding 2.20 meters in height.**

Art. 3 - The use of parking spaces is at an hourly rate. The rate shall be paid for the entire hour, even if not fully utilized. Payment for parking shall be made, 24 hours a day at the automatic cash machines in the parking lot. From the time of payment 15 minutes are allowed for the vehicle to leave the parking lot. **In case the stop is less than 15 minutes, the user may exit the parking lot free of charge by inserting the ticket collected at the entrance, directly into the exit column.**

Failure to pay the parking fee entitles the Company to detain the vehicle pursuant to Art. 2756 Civil Code.

Art. 4 - **The stalls reserved for the disabled, as provided for in the relevant regulations, are located in the square in front of the Bus Station on the ground floor. Said spaces, in order to facilitate their use by users, are outside the parking lot and near the entrance to the terminal.**

Art. 5 - The parking lot consists of a basement level and a ground floor level. Users will be able to access the ground level from the internal ramp only if the illuminated sign placed at the beginning of the ramp indicates free spaces. Users parking on the ground floor level must exit through the designated exit gate located on the ground floor ground floor and under no circumstances should they re-enter the basement floor from the ramp, which is one-way.

The user who enters the ground floor despite the full warning displayed in the appropriate panel will necessarily have to exit the parking lot using the appropriate exit gate located on the ground floor. Autostazione di Bologna shall not be liable for damages resulting from behavior that differs from those reported in the following article.

Art. 6 - The driver of the vehicle, as user of the service, is required:

(a) To collect at the entrance the ticket, which is the only valid document for the exit of the parked car, unless he/she is the holder of a season ticket card, if permitted;

(b) To perform all the necessary maneuvers to park the vehicle within one of the designated stalls, leaving it perfectly braked, with the engine off, taking all necessary precautions for the safety of persons and their own and third parties' property. The parking of the vehicle must not impede the maneuvering and/or parking of other cars in the adjacent spaces.

Bologna Bus Station will consider itself authorized to intervene to move the car that is not parked in an appropriately, without any charge for any damage caused, while the costs of removal will be at the total expense of the user and they must be paid by the same before going out with the car from parking.

c) Not to leave in the parked cars any flammable or explosive materials and/or substances, animals or objects whose presence may for any reason constitute danger.

d) To make the payment of the parking fee when collecting the vehicle according to the rates provided and displayed at the entrance to the parking lot, which are understood to be known and accepted by the user. In the event that the exit of the vehicle occurs without payment of the fee, due to momentary malfunction of the facilities or for any other reason, the user, however required to pay, must contact the offices of the Bologna Bus Station within the 5 (five) days following, to communicate his data and regularize the position. After this deadline, the user will be charged for any further economic burden related to visas, payment reminders and anything else necessary to obtain reimbursement, with an initial surcharge of € 10.00 (ten) as a lump-sum compensation for administrative expenses.

Art. 7 - In the parking lot, the rules governing the movement of vehicles must be observed. The customer is obliged to scrupulously observe the signs and all legal provisions.

Within the parking lot, circulation must be carried out strictly at a "walking pace."

In particular, it is strictly forbidden:

- 1) To smoke and use open fire or lights;
- 2) To carry out unloading and storage of objects of any kind and especially if flammable;
- 3) Of refueling, making repairs, changing oil, washing the vehicle, recharging batteries, accumulators etc. and in general to carry out any operation of maintenance of the vehicle;
- 4) To park for a long time with the engine running and to honk the horn;
- 5) To park vehicles with tank leaks or affected by other defects likely to cause damage to the parking lot;
- 6) To park without authorization vehicles without regulatory plates and replacement plates authorized
- 7) To access and park vehicles fueled by liquefied petroleum gas (L.P.G.), with the exception of vehicles with equipment equipped with the safety systems in accordance with ECE/UN 67/01 Regulation.
- 8) To park the vehicle in the transit areas and in front of the emergency exits;
- 9) To enter/exit the parking lot with vehicles exceeding the maximum height marked at the entrance.

Art. 8 - In case of loss of the entry ticket by the user, the exit of the vehicle will take place against payment of the parking fee only if the user can prove, by showing an identity document, the legitimate possession of the vehicle. Bologna bus station is not liable of damages resulting from the improper use of parking tickets by anyone.

Art. 9 - The monthly subscription user will be provided with a parking access card.

Payment of the subscription amount will be made by the 15th day of the subscription month, The cancellation must be communicated in writing at least 15 days before the expiration date; otherwise otherwise the subscriber will be equally liable for payment of the following month.

Art. 10 - The company is not liable:

- For damage caused by other users and/or third parties to parked vehicles
- For theft consumed and/or damage caused to objects inside the vehicle or to the vehicle itself, including the removable accessories.

Art. 11 - The parking lot is not guarded, Autostazione di Bologna S.r.l. does not offer and does not propose any service of custody and is not liable for either damage or theft suffered by the vehicles and/or objects left inside the same during the parking period. In the event of impacts, collisions, accidents, investments, etc. within the parking lot, the right to compensation for damages will then be exercised by the injured party against the party who caused such events, any liability on the part of the property and/or the manager of the parking lot.

Art. 12 - Any claims for damages must be proven and exposed to the staff of the parking lot before leaving the parking lot with the vehicle.

Art. 13 - In collecting the parking entrance ticket, the user acknowledges that he/she is aware of and accepts unconditionally the type of service offered and all the rules contained in these regulations committing himself to scrupulously abide by them.

Art. 14 - In case of non-acceptance of these Regulations, the user is allowed to leave the parking lot without payment of consideration, provided that this is done without delay and in any case within the tolerance limit of 15 minutes.
