TOURIST TAX 2025

Dear Guest, before leaving please make sure you have paid the tourist tax to the manager of the accommodation facility.

The Municipality of Comacchio, with Municipal Council resolution no. 77 dated 27/07/2017, has established, starting from December 1, 2017, the tourist tax for those staying in the accommodation facilities of the territory.

AIM OF THE TOURIST TAX

The tourist tax finances interventions regarding tourism, including those that support the accommodation facilities, maintenance, use and recovery of local cultural and environmental heritage, as well as local public services.

WHO PAYS THE TAX

The persons not resident in the Town of Comacchio who stay in the accommodation facilities, including houses and flats for tourism use, within the municipal territory must pay, according to the modalities established in the Municipal Regulation, the tourist tax for each overnight stay up to a maximum of 14 (fourteen) nights.

WHO DOESN'T PAY THE TAX

The following are exempt from the payment of the tourist tax:

1. minors up to twelve years of age;
2. volunteers that offer their service on the municipal territory in case of environmental and humanitarian emergencies;
3. personnel of the local and state police forces, armed forces, national fire brigade and civil protection that stay here for service;
4. coach drivers and tour leaders of travel agencies whose activity is to assist organised groups. The exemption is applied for each coach driver and a tour guide every twenty-five participants;
5. dependents working for the manager of the accommodation facility;
6. disabled persons having 100% invalidity with suitable certification and their carer (one person per disabled person).

HOW TO PAY

The tax is paid directly to the manager of the accommodation facility where the person has stayed together with the amount foreseen for the stay.

Always ask the manager for the receipt or similar attesting the payment of the tourist tax.
